Annex 1: Summary of the proposed duties for information purposes only

In accordance with Article 19a of Regulation (EU) 2016/1036 of the European Parliament and the Council of 8 June 2016 on protection against dumped imports from countries not members of the European Union¹ ('the basic Regulation'), as last amended by Regulation (EU) 2018/825 of the European Parliament and of the Council of 30 May 2018², and with regard to the anti-dumping investigation concerning imports of birch plywood originating in Russia, the Commission provides, with this annex, a summary of the proposed provisional duties for information purposes only.

All exporting producers, for whom an individual calculation was done, will receive details of the calculation of their individual provisional anti-dumping duties.

Product scope.

The products subject to the provisional duties is plywood consisting solely of sheets of wood, each ply not exceeding 6 mm thickness, with outer plies of wood specified under subheading 4412 33, with at least one outer ply of birch wood, whether or not coated, originating in Russia, currently falling within CN code ex 4412 33 00 (TARIC code 4412 33 00 10).

Provisional anti-dumping duty

The rates of the provisional anti-dumping duty expressed on the CIF Union border price, customs duty unpaid, shall be as follows:
