# Fitt-Ness

Fostering Innovation & the Twin Transition for iNclusive EnvironmentS and Smart homes

FITT-NESS aims to provide a comprehensive approach to increase the capacity of 2 less developed and 1 outermost regional innovation ecosystems – Portugal (North), Spain (Murcia) and Italy (Sicily) – to deliver concrete interregional innovation investments within the smart homes and inclusive environments value chain related to the furniture sector, benefitting from the learning of a more developed ecosystem, in Italy (Lombardy).

















The project lasts 24 months, from 01/11/2024 to 31/10/2026

#### **OBJECTIVES**

- Conduct comprehensive mapping and analysis of the capabilities, market trends, challenges, opportunities and barriers of the furniture sector in the 4 regional innovation ecosystems.
- Develop a more skilled workforce, building concrete capacities on business and investment planning, by delivering tailored training, skill development, and knowledge transfer activities with a special focus on the digital and green transition.
- Deliver comprehensive advisory and business support services to innovation intermediaries, tailored to the living environment sector.
- Support the 3 less developed/outermost S3 regions in building and enhancing their innovation ecosystems.
- Establish a robust transnational community, enabling feedback loops for networking, experience sharing and good practices elicitation, with a long-term partnership strategy, ensuring the sustainability and effective policy impact.



### **ACTIVITIES**

## **Ecosystem Building, Mapping, and Needs Assessment**

- Identify and map the primary challenges and opportunities within the Smart Specialization Strategy (S3) roadmap for each region.
- Establish FITT-NESS Communities in each of the four target regions
- Formally organize FITT-NESS Communities, with a coordination group that represents the quadruple-helix of actors

# **Capacity Building, Training, and Networking**

- Directly support SMEs and their innovation intermediaries
- Provide training, advisory, and business services aimed at enhancing skills, knowledge, and strategic capabilities within SMEs.
- Conduct pilot initiatives to test approaches, while fostering dialogue among stakeholders to promote collaboration and strengthen ecosystem partnerships.

## **New Governance and Sustainability**

- Develop new governance models and activate synergies to improve stakeholder participation and project sustainability.
- Create a catalogue of governance models and benchmarks to support sustainable practices, including policy recommendations aimed at long-term impact and scalability.
